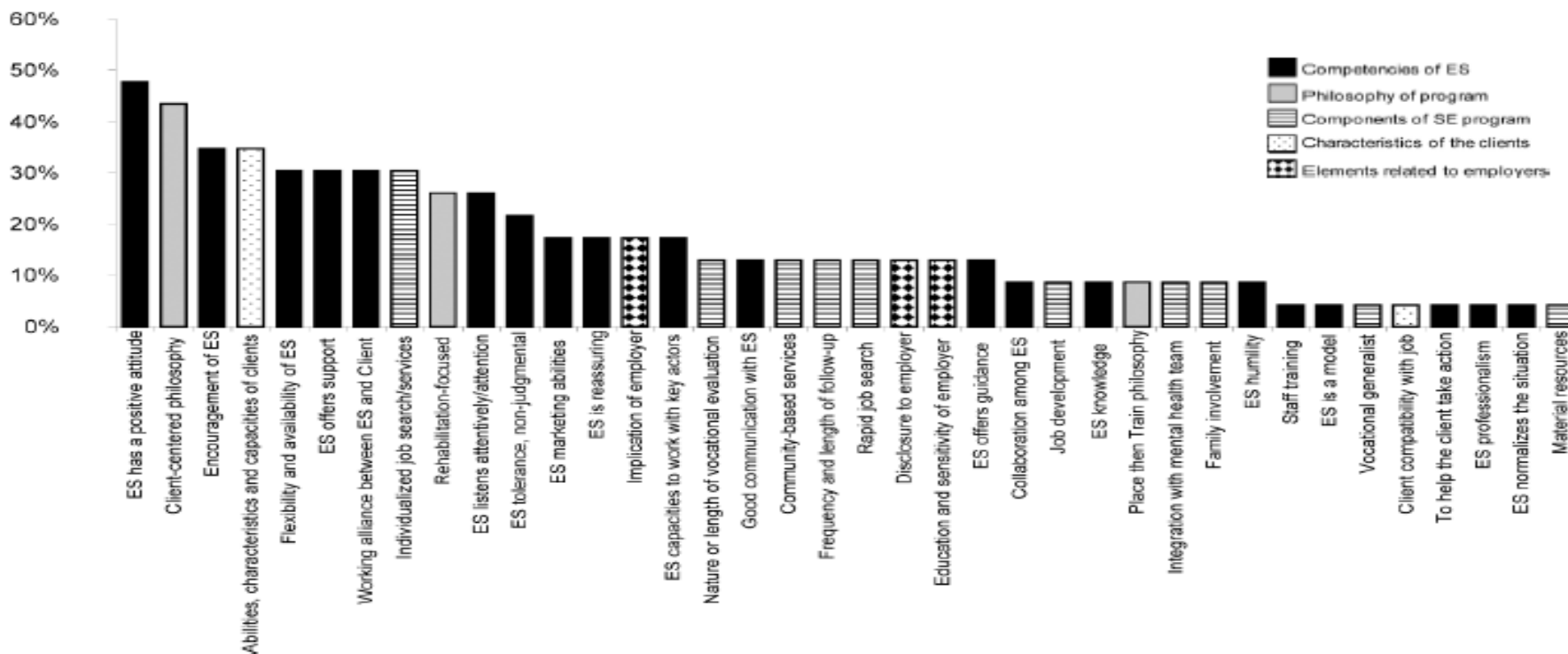


Fig. 1. Employment specialists' perspectives on salient elements for obtaining a job.

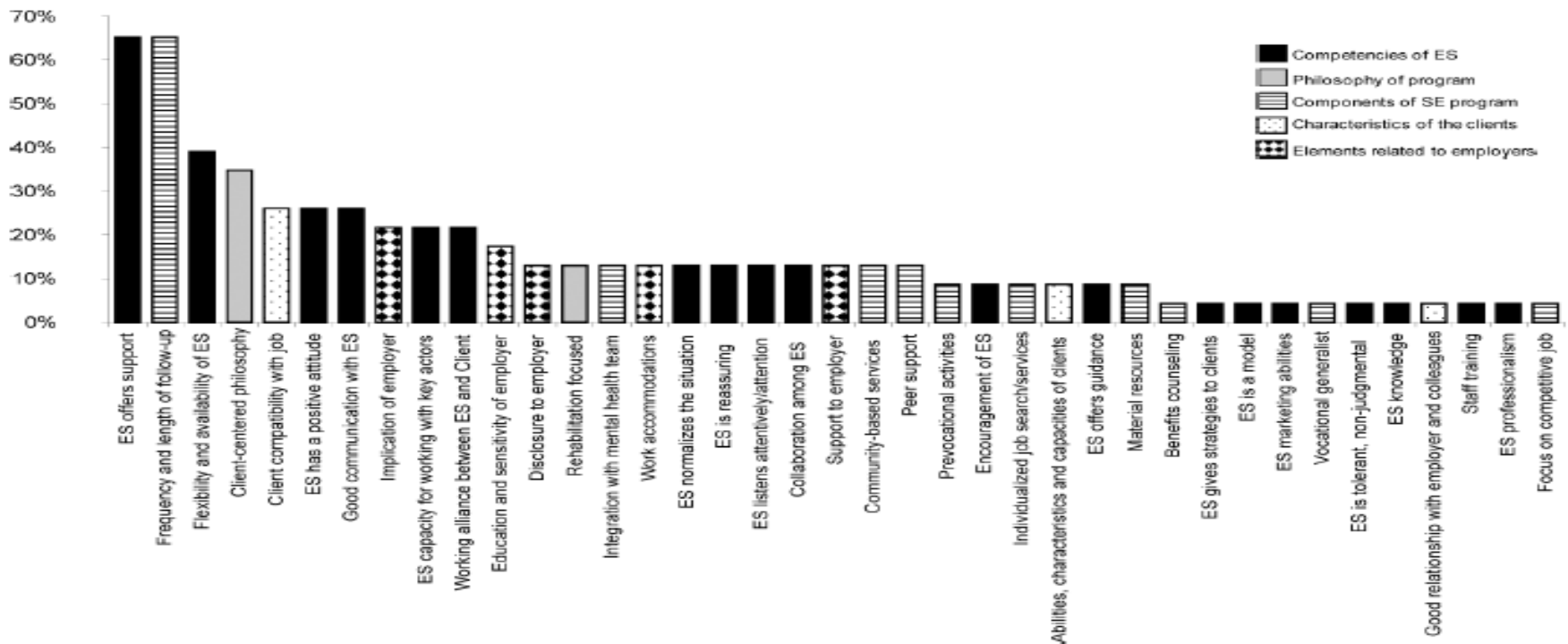


Fig. 2. Employment specialists' perspectives on salient elements for maintaining a job.

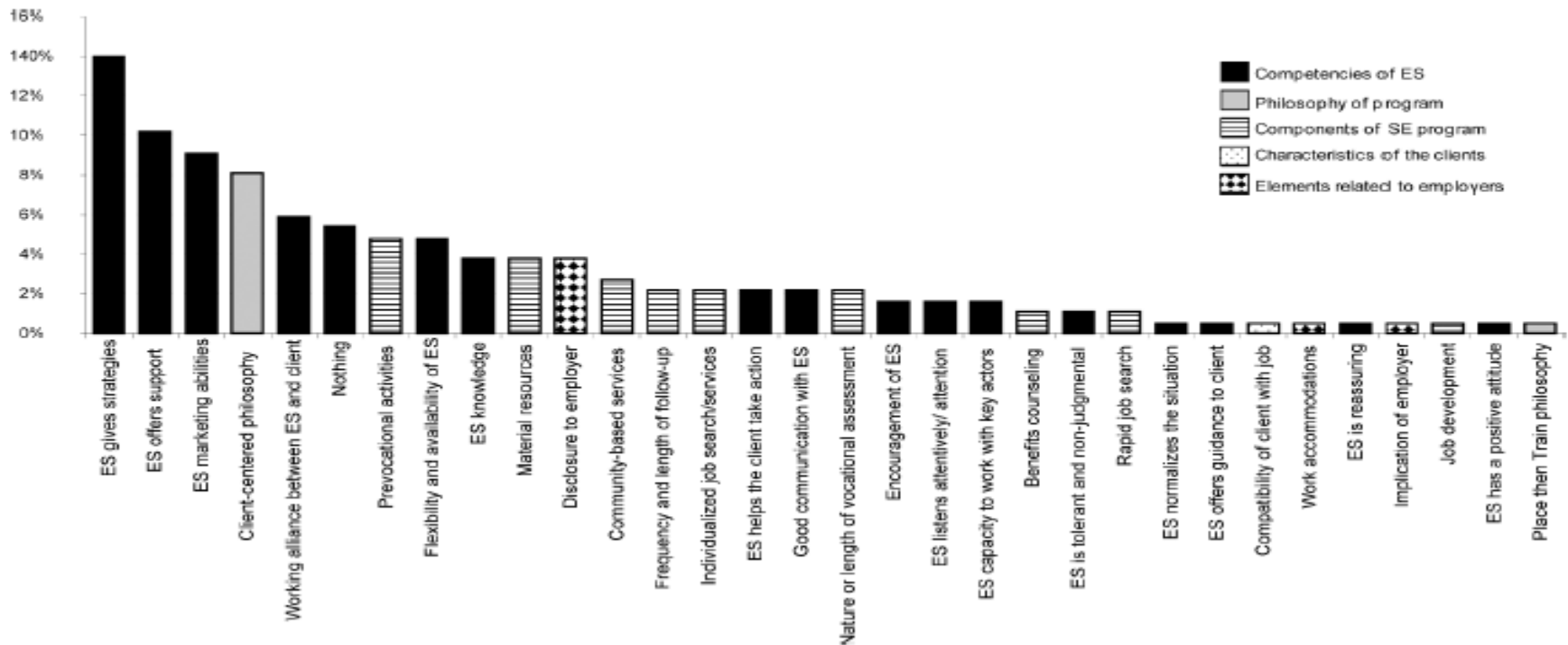
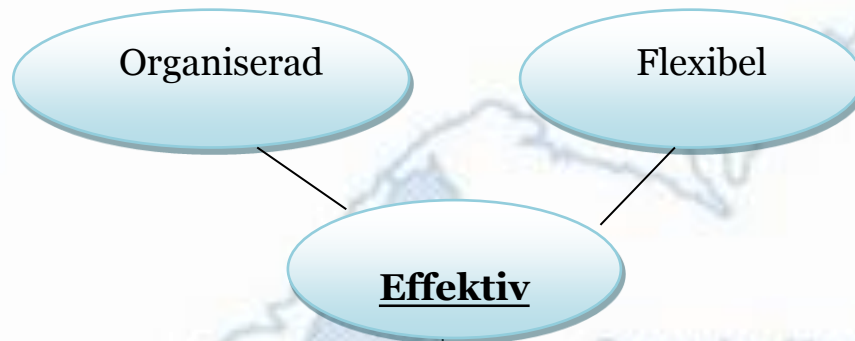
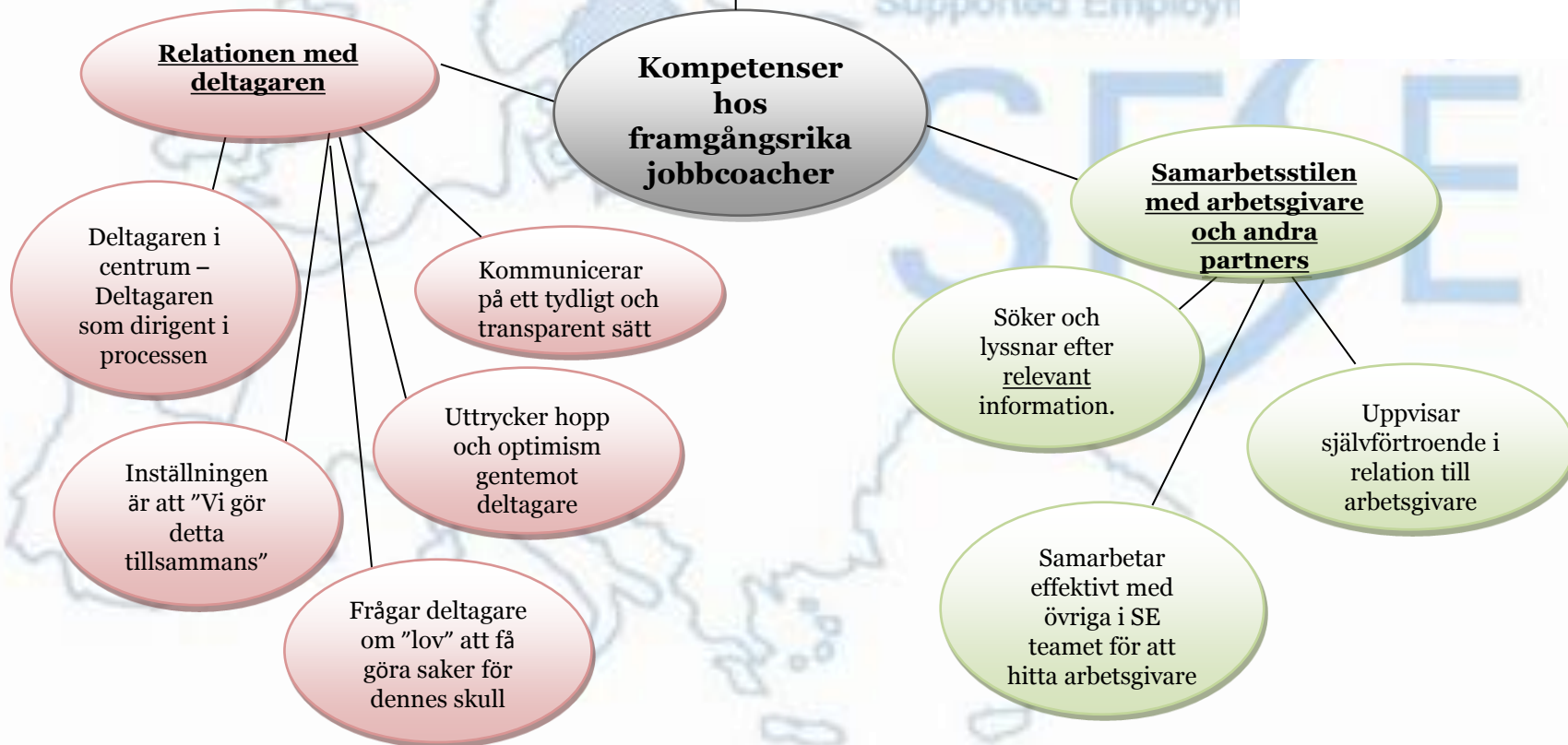


Fig. 3. Clients' perspectives on salient elements for job integration.
